Short description of the case is that, one Sri Om Prakash Sharma filed an F.I.R in the Chandmari Police Station on 21.08.1992 inter-alias alleged that on 21.08.1992 in the evening at about 8.45 p.m, there happened to be a dacoity at his residence. During investigation Chandmari police picked up hundreds of youth for investigation. At that time, the candidate was the District President of a Student Union (NSUI) of a National Political Party (INC) and on request of some of the local youths, he protested before the Officer-in-Charge of Chandmari P.S. against the police harassment on some of the innocent local youth. Later on due to massive protest of the student community headed by the candidate the police released some of the innocent youth but on 03.10.1992 the Officer-in-Charge of Chandmari P.S. arrested the candidate with some false, baseless and fabricated allegations and subsequently the candidate was released on bail by the Hon'ble Court of the Chief Judicial Magistrate, Kamrup.
