Brief Description of the Case:

One Shoshidhar Pasoni the officer-in-charge of Nagaon P.S. lodged an FIR on 22-12-2009 alleging inter-alia that on 22-12-09 at 1.57 PM he received a phone call from honourable SP Nagaon whereby the SP informed him that some people have

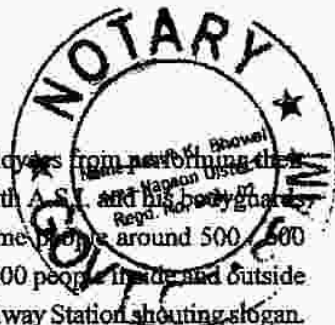

blockade the train and also obstructed the workers and the employees from performing their duty on the railway track. On receiving the information alongwith A.S.I. and his body guards went to Haibargaon Railway Station for enquiry. He found some people around 500-500 shouted and blockade the Kolong Kopili Train. He also found 500 people inside and outside the train and he also found about 150 people coming towards Railway Station shouting slogan. Those people were unlawfully assembled and anticipating that the move may destroy Govt. Property. They were directed towards the North Direction. Those people were instigated by Nurul Amin Chowdhury and one another, got furious and pelted stone. Immediately Police resorted into light baton but the unruly people at the instigation of Nurul Amin Chowdhury by holding the uniform of police personel and tried to snatch away their arms and again pelted stones and as a result received injuries. It was around 2.20 PM A.S.I. Ghanakanta Talukder received injuries on his head and also policeman Subash Barman, Afazuddin Ahmed & Imtiaz Ali received injuries. As the Megistrate did not reach the spot we resorted to firing to the zero. At that point of time the megistrate reached the spot he deploy ASI Pradip Barua to take over the charge and he alongwith other injured police Officials went to BP Civil Hospital for treatment. (Certified copy of the FIR enclosed).

The Hon'ble Court has granted bail in above mentioned case.

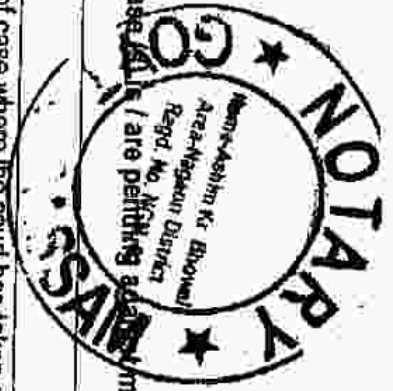

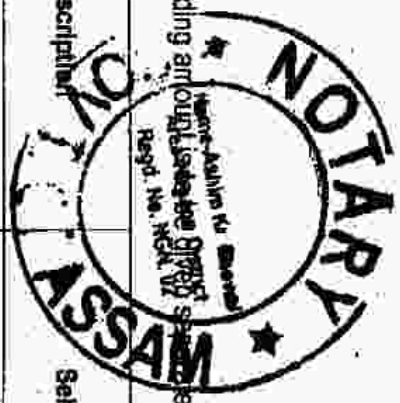
