सं. 76/असम-लोकसभा/11/2009(5):- यतः भारत निर्वाचन आयोग का यह समाधान हो गया है कि लोकसभा के लिए साधारण निर्वाचन, 2009 में 11.-कालियाबोर संसदीय निर्वाचन क्षेत्र से निर्वाचन लड़ने वाले अभ्यर्थी, श्री पौल नायक, लोक प्रतिनिधित्व अधिनियम, 1951 तथा तद्धीन बनाए नियमों एवं आदेशों द्वारा अपेक्षित अपने निर्वाचन-व्यर्थों का लेखा दाखिल करने में असफल रहे; और

यतः श्री पौल नायक, ने निर्वाचन आयोग द्वारा सम्यक सूचना दिए जाने पर भी उक्त असफलता के लिए कोई कारण या स्पष्टीकरण नहीं दिया गया है, और निर्वाचन आयोग का यह समाधान हो गया है कि उनके पास उक्त असफलता के लिए उनके पास कोई उपयुक्त कारण या न्यायौचित्य नहीं है;

अतः अब, निर्वाचन आयोग, एतद् द्वारा लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 10-क के अनुसरण में, श्री पौल नायक, को संसद के किसी भी सदन के या किसी राज्य/संघ राज्य क्षेत्र की विधान सभा अथवा विधान परिषद के सदस्य चुने जाने और होने के लिए इस आदेश की तारीख से तीन वर्ष की कालावधि के लिए निरर्हित घोषित करता है:-
