With reference to the subject cited above, I would like to inform you that while inspecting the Candidates Register on 08-04-2011 by the Expenditure Observer, the following Discrepancies were noticed in your Expenditure Register.

- m) Bank register- source of cash deposit (self) is not explained after cash deposit (in the cash book) of Rs. 2,50,000/- on 24-03-2011 out of cash in hand of Rs. 5,00,000/- as per declaration of assets and bank deposit of Rs. 5000/- on 24-03-2011. The Candidate did not have sufficient cash to deposit Rs. 5,00,000/- in bank subsequently. His affidavit of assets statement appears to be untrue.
