5	Passbook issued by Public Sector Banks/ Post office and Kisan Passbooks (Accounts opened before 28.2.2011)
6	Property Documents such Pattas, Registered Deeds etc
7	SC/ST/OBC Certificate issued by Competent Authority on or before 28.02.2011
8	Pension Documents such as Ex-Servicemen's Pension Book/ PPO/ Ex=Servicemen's Widow/ Dependent Certificates, Old Age Pension Order, Widow Pension Order, issued on or before 28.02.2011
9	Freedom Fighter Identity Card
10	Arms License issued on or before 28.02.2011
11	Certificate of Physical Handicap by Competent Authority issued on or before 28.02.2011
12	Job Cards issued under NREGA with photograph issued up to 28.02.2011
13	Health Insurance Scheme Smart Cards with photograph (Ministry of Labour's Scheme) issued up to 28.02.2011
14	Railway Identification Cards issued on or before 28.02.2011
15	Certificate issued by the Management of Tea Gardens/ Tea Estates to the employees of the Tea Gardens/ Tea Estates on or before 28.02.2011
16	School Certificates issued by Schools run/ recognized by the Government or Local Authorities on or before 28.02.2011
17	Permanent Resident Certificate issued by the District Administration on or before 28.02.2011
18	Revenue Certificate issued by the DM/ADM/SDM/EM/Circle Officer/ Mauzadar on or before 28.02.2011

19	Certificates issued by Panchayati Raj Institutions on or before 28.02.2011 (but those issued only under the signature of the Chief Executive Officer of Municipal Corporation/ Municipal Board/ Town Committee, Panchayat Secretary or Government Official of equivalent rank)
20	Revenue payment receipts for Telephone, Electricity and Water (issued on or before 28.02.2011)
21	Duplicate copy of the enumeration pad issued to households at the time of enumeration for intensive revision of Electoral Rolls w r t 1.1.2005
22	Any Government document carrying the photograph of the elector issued by any State Government Office/ agency before 28.02.2011 (signed only by Officers of the State Government/ Central Government/ State Government PSU/ Central Government PSU)

**Note 1:** In respect of the electors who do not have any of the prescribed documents mentioned above, they alone shall be identified by the Gaon Burahs and Booth Level Officers of the concerned PS

**Note 2:** Any document which is available only for the Head of the family shall be allowed for the purpose of identification of other members of the family provided all such family members come together. Similarly, any document in the name of any other member of the family could also be used for identification of other members, provided the other members can be identified on the basis of such document

**Note 3:** In the case of overseas electors who are registered in the electoral rolls under Section 20A of the RP Act, 1950, based on the particulars in their passport, they will have to produce their original passport for their identification in the polling station
