1. In schedule 5:-

 - (b) If the vehicle is owned by the candidate/his relative /agent are used for election purpose, national cost of hire of all such vehicles, except one vehicle if owned and used by the candidate national cost of fuel and drivers salary for such vehicles, shall be included in total amount of expenditure in the above table.

In all schedules if any expenditure on goods and services, provided by the political party, or provided by the any person/ company/ firm/ associations/ body of person etc. on behalf of the candidate, then the national market value of such goods or services are to be indicated in respective columns.
3. In part -III, all Lump - sum amount of fund received from the political party or others or the candidate's own funds, should be mentioned date wise. In all such cases such amounts are required to be first deposited in the bank account of the candidate, opened for election expenses.
4. Each page of the Abstract Statement should be signed by the candidate.
