- Tender cash at the cash counter after scrolling the pay-in-slip, verified and signed by the official of the branch.
- Ensure counting of Notes before leaving the Cash Counter
- Remit notes in unstapled/unstitched conditions, as per RBI norms. Also ensure that the note is not a soiled/damaged one. The same may be exchanged separately.
- Preserve the Cheque Book, Pass Book, ATM Card & Debit Card in a safe custody.
- In case of loss, steal or damage of the Cheque Book, Pass Book, ATM Card or Debit Card, inform the Branch/customer care immediately.
- Ensure maintenance of sufficient balance in the account while issuing cheque. Return of cheque for want of fund, is a criminal offence and may be sued in the Court of Law.
- Nomination Facility may be availed for quick disposal of the balance in the account in case of death of account holder. If availed, the mandate 'Nomination Registered' will be recorded on the face of the passbook. In addition, the name of the nominee will also be mentioned if the customer demands so. Deletion/Replacement of nominee is also allowed.
- Interest is paid as per RBI directives on half-yearly rest on daily product basis.
- Facility for standing instruction involving credit to another account may also be availed of with charges.
- Quote your account number while corresponding with the bank.
- Intimate the Bank immediately upon change in your recorded address with valid address proof.
- Ensure updation of your pass book at a regular interval. In case of any discrepancy, inform the branch officials accordingly for rectification.
- For inoperative account (not being operated/dormant for a period of 2 years or more) attracts reduction of incidental charges on quarterly basis.
- Limit in No. of withdrawals in S.B. A/c - 50 in a calendar half year, exceeding the limit will attract service charge.
- Customer has the facility to get the pass book updated away of the Branch of the Bank.
