NOTIFICATION

No.100/AS-LA/01/2016: - WHEREAS, the seat of Shri Mansing Rongpi in the Legislative Assembly of the State of Assam, elected from 20-Baithalangso (ST) Assembly Constituency, has become vacant by reason of resignation with effect from 13th July,2016; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW, THEREFORE, in pursuance of Sections 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

- (A) Calls upon the said 20-Baithalangso (ST) Assembly Constituency in the State of Assam, to elect, before the 24th November,2016 (Thursday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person belonging to any of the Scheduled Tribes of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State;
- (B) Appoints, with respect to the said election, -
 - (a) The 2nd November,2016 (Wednesday), as the last date for making nominations;
 - (b) The 3rd November,2016, (Thursday), as the date for the scrutiny of nominations;
 - (c) The 5th November, 2016, (Saturday), as the last date for the withdrawal of candidatures;
 - (d) The 19th November,2016, (Saturday), as the date on which a poll shall, if necessary, be taken; and

- (e) The 24th November,2016 (Thursday), as the date before which the election shall be completed; and
- (C) Fixes the hours from 07.00 A.M. to 04.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
