No.100/AS-LA/02/2017:- WHEREAS, the seat of Shri Pradan Baruah in the Legislative Assembly of the State of Assam, elected from 113-Dhemaji (ST) Assembly Constituency in the State, has become vacant on 30<sup>th</sup> November, 2016 by reason of his resignation; and

2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. NOW, THEREFORE, in pursuance of Section 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

(A) Calls upon the said 113-Dhemaji (ST) Assembly Constituency in the State of Assam, to elect, before the 29<sup>th</sup> May, 2017 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person belonging to any of the Scheduled Tribe of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State;

(B) appoints, with respect to the said election, -

- (a) The 21<sup>st</sup> March, 2017, (Tuesday), as the last date for making nominations;
- (b) The 22<sup>nd</sup> March, 2017, (Wednesday), as the date for the scrutiny of nominations;
- (c) The 24<sup>th</sup> March, 2017, (Friday), as the last date for the withdrawal of candidatures;

- (d) The 09<sup>th</sup> April, 2017, (Sunday), as the date on which a poll shall, if necessary, be taken; and
- (e) The 15<sup>th</sup> April, 2017, (Saturday), as the date before which the election shall be completed; and
- (C) Fixes the hours from 07.00 A.M. to 04.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
