- (A) appoints, with respect to the said election in each of the above mentioned States. -
- (a) the 28<sup>th</sup> January, 2014 (Tuesday), as the last date for making nominations;
  - (b) the 29<sup>th</sup> January, 2014 (Wednesday), as the date for the scrutiny of the nominations;
  - (c) the 31<sup>st</sup> January, 2014 (Friday), as the last date for the withdrawal of candidatures;
  - (d) the 7<sup>th</sup> February, 2014 (Friday), as the date on which a poll shall, if necessary, be taken; and
  - (e) the 10<sup>th</sup> February, 2014 (Monday), as the date before which the election shall be completed; and
- (B) fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken in all the above mentioned States, on the date specified above, for the election.
