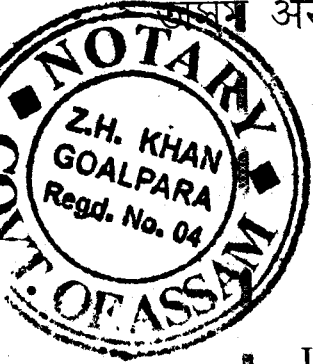

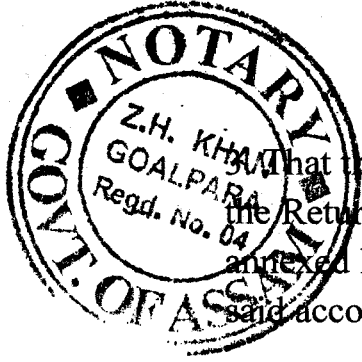

5. In case of any violation and disturbance of law and order due to use of the loudspeaker, the applicant/organiser will be held responsible.
6. Permissible Ambient noise levels notified by the Government of India under Environment (Protection) Act, 1986 should be maintained during the use of microphones. During the use of microphone in open air, sound limiter should be attached with amplifier for regulating noise level.
7. In case of violation of any of the above conditions the permission/order for use of loudspeaker will immediately be deemed to have been withdrawn and proceedings will be started against the applicant/organiser under violation of Model Code of Conduct.
