Whereas, I, the undersigned, am satisfied that you/OP were in occupation of the Public Premises mentioned in the Schedule below for the period from 1.5.2009 to 16.6.2009,

And whereas by a Show-cause Notice dated 11.03.2015, you were called upon to show cause on 9.04.2015, why an order requiring you to pay a sum of Rs.3011/- (Rupees three thousand eleven only) for the period from 01.5.2009 to 16.6.2009 together with interest should not be made in respect of the said premises. Notices dated 8.6.15, 3.9.15 and 17.11.15 were issued for hearing on 27.8.15, 29.10.15 and 26.11.15 none appeared for OP. Sufficient opportunity has been given but you failed to appear on 26.11.2015

And whereas, you have not made any objections nor have produced any evidence.

The Show-cause Notice dated 15.1.2015 and subsequent Notices dated 8.6.15, 3.9.15 and 17.11.15 under sub-section (3) of section 7 of the Public Premises (Eviction of Unauthorised Occupants) Act, 1971 were sent to Sh. Anwar Hussain, Ex-MP but none appeared and no reply has been received from them. As per the report on the website of India Post last Notice dated 17.11.15 sent through Regd./AD post was delivered to OP on 24.11.15. Sh. P.C. Barolia, DR from RPS stated that OP is deliberately avoiding to appear in this matter. Sufficient opportunity for hearing has been given to OP who failed to appear at the time of hearing on 26.11.15 and therefore the case was fixed for ex-parte order. I am inclined to accept the prayer of RPS that License fee amounting to Rs. 3011/- as calculated by RPS for the period from 01.5.2009 to 16.6.2009 is liable to be paid by OP/ Sh. Anwar Hussain, Ex-MP.

Now, therefore, in exercise of the powers conferred on me by sub-section (1) of Section 7 of Public Premises (Eviction of Unauthorised Occupation) Act, 1971. I hereby order you to pay a sum of Rs. 3011/- (Rupees three thousand eleven only) assessed as arrears of dues of license fee on account of your occupation of the premises.

In exercise of the powers conferred by sub-section (2A) of section 7 of the said Act, I also hereby require you to pay compound interest @8% per annum on the above sum w.e.f. 6.2.2015 (from the date of application from the Deptt. to initiate proceeding of recovery of license fee before Estate Officer) till its final payment. Arrears of Rs.3011/- with interest above said be paid within one month from the date of publication of the order.

In case the said sum is not paid within the said period or in the said manner, it will be recovered as arrears of land revenue through the Collector.
