NOTIFICATION

No. 100/AS-LA/1/2022/NES-II.- WHEREAS, the seat of Shri Sarbananda Sonowal in the Legislative Assembly of the State of Assam elected from **99-Majuli (ST) Assembly Constituency**, has become vacant on **28.09.2021**, by reason of his resignation.

2. **WHEREAS**, a bye-election is to held for the purpose of filling the vacancy so caused;

3. **NOW THEREFORE**, in pursuance of Section 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

(A) **calls upon** the said **99-Majuli (ST) Assembly Constituency** in the State of Assam, to elect before **12th March, 2022 (Saturday)** and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person belonging to any of the Schedule Tribe of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State;

(B) **appoints**, with respect of the said election,-

(a) the **17th February, 2022 (Thursday)**, as the last date for making nominations;

(b) the **18th February, 2022 (Friday)**, as the date for scrutiny of nominations;

(c) the **21st February, 2022 (Monday)**, as the last date for the withdrawal of candidatures;

(d) the **07th March, 2022 (Monday)**, as the date on which a poll shall, if necessary, be taken: and

(e) the **12th March, 2022 (Saturday)**, as the date before which the election shall be completed;

(C) **fixes the hours from 7.00 A.M. to 5.00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
