Notes on Financial Statement for the year Ended 31st March 2022

NOTE 20: NOTES TO ACCOUNTS

I. BACKGROUND OF THE PARTY

Bharatiya Gana Parishad is a regional party registered with the Election commission of India as a political party under Section 29A of the Representation of the People Act, 1951 Vide order No. F. No. 56/175/2015/PPS-I Dtd. 11th March 2016. The object of the party involves building a developed democratic India based on the principles of equal opportunity of all the citizens fighting against influence of money power and muscle power.

II. BASIS OF PREPARATION

These financial statements have been prepared to comply in all material respects with the accounting standards and guidance notes issued by the Institute of Chartered Accountants of India. The financial statements have been prepared under the historical cost convention on accrual basis. The accounting policies have been consistently applied by the party, and are consistent with those used in the previous year.

NOTE 21: SIGNIFICANT ACCOUNTING POLICIES

I. USE OF ESTIMATES:

The preparation of financial statements, in conformity with Indian GAAP requires management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets, liabilities and disclosure of contingent liabilities at the end of the reporting period. Although these estimates are based upon management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future periods.

II. FIXED ASSETS:

Fixed assets are stated at cost less accumulated depreciation, amortization and impairment losses if any. Cost comprises the purchase price and any directly attributable cost of bringing the asset to its working condition for its intended use. Borrowing costs relating to acquisition of fixed assets which takes substantial period of time to get ready for its intended use are also included to the extent they relate to the period till such assets are ready to be put to use.

III. REVENUE RECOGNITION:

All items of revenue are recognized in accordance with Accounting Standard (AS - 9).

IV. PROVISIONS AND CONTINGENCIES:

A Provision is recognized for a present obligation as a result of past events if it is probable that an outflow of resources will be required to settle the obligation and in respect of which a reliable estimate can be made. A contingent liability is disclosed, unless the possibility of an outflow of resources is remote. Contingent assets are neither recognized nor disclosed in the financial statements.

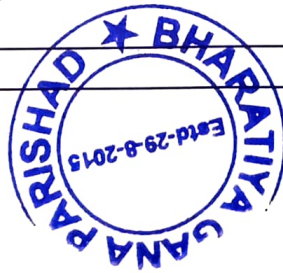

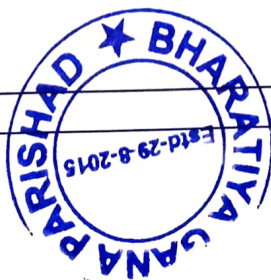
