- (d) the 30<sup>th</sup> May, 2013 (Thursday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 3<sup>rd</sup> June, 2013 (Monday), as the date before which the election shall be completed; and
- (B) fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
